



# Fee Information for Private and Canadian Organization Accreditation

Fees associated with COA's four-year Private and Canadian Organization Accreditation include the following:

## **Application Fee**

There is a nonrefundable application fee of \$750 (not applicable for reaccreditation) that is paid at the time of application.

## **Accreditation Fee**

COA will calculate the accreditation fee of a Private and Canadian Organization using a sliding scale based on the organization's most recent audited annual gross revenues and total support minus pass through funds.

The following is a list of deductions COA allows:

- Pass through funds associated with foster care payments;
- Pass through funds associated with subsidized adoption payments;
- In-kind donations;
- Emergency assistance to clients;
- Pass through funds to contract providers (human service agencies, not individuals); and
- Revenue related to programs/services that are exempt from the COA review

Fees start at a minimum of \$7,392 for an organization with revenue of \$500,000 or less, and increase accordingly. A fee schedule is provided on page two. Organizations affiliated with one of COA's Sponsoring Organizations are eligible for a 25% discount on the accreditation fee.

At least 50% of the accreditation fee is due when the organization returns the signed Accreditation Agreement. The accreditation fee must be paid in full prior to the on-site review. The reaccreditation fee is same as the first-time fee.

## **Site Visit Fee**

The organization pays a flat fee of \$2,200 per Reviewer for a two-day on-site review, plus \$475 per day multiplied by the number of Reviewers for each additional day. Site Visits are comprised of a minimum of two reviewers for two days and increase in team size and length depending on the number of sites and types of services reviewed. The fee covers all costs and expenses of the Site Visit, including, but not limited to, travel, hotel, meals, and incidentals. The Site Visit fee is invoiced immediately after the visit.

## **Maintenance of Accreditation Fee**

There is an annual Maintenance of Accreditation fee of \$400 that is paid on the first, second and third anniversary of the achievement of accreditation.
