Linda will talk about foster care and the CPA side, Karen will talk about BRS, and Brian will talk about the process and summarize the WACF issues that were raised at the CPA and Intensive Services division meetings last week. Brian will also talk about how early intervention services and preventative services (FPSS) should be included in the continuum. The focus will be on how to move forward and how WACF can help with the implementation of recommendations.
